Modified Research Question & Hypothesis



Research Question—How are global healthcare, global leadership, and evidence-based practice competencies characterised and integrated within accredited postgraduate programmes in global healthcare leadership, particularly for non-clinical executives, worldwide?



Hypothesis for the Dissertation Research—Accredited postgraduate programmes in global healthcare leadership *do not sufficiently* integrate global healthcare, global leadership, and evidence-based practice in the training of non-clinical executives.



The findings of this research support the hypothesis.

Seven Noteworthy Preliminary Findings



(1) There is a significant lack of peer-reviewed research on global healthcare leadership postgraduate programmes, necessitating the use of primary source grey literature.

(2) There is a notable gap in research on the integration of evidence-based practice within identified global healthcare—leadership & management—programmes.

(3) Only **nine** postgraduate programmes worldwide focus on global healthcare leadership and management, all based in the UK.

(4) Of the nine UK programmes, only **three** specifically focus on global healthcare leadership. Of those three, **two** mention evidence-based practice, while only **one** fully integrates it into their website.

(5) Only **one** global healthcare leadership programme website provides faculty details. The remaining do not display faculty with doctorates aligned to the curriculum (e.g., global healthcare, global leadership, evidence-based practice).

(6) All **three** UK-based GHL programmes are open to clinical and non-clinical professionals, but only one explicitly states this dual focus.

Advancing Global Healthcare Leadership as an Academic Discipline

01

Advocate for the formal establishment of Global Healthcare Leadership as a recognised interdisciplinary academic discipline.

02

Propose the strategic development of **interdisciplinary** Master of Science programmes in Global Healthcare Leadership, integrating the core domains of global healthcare, global leadership, and evidence-based practice.

03

Urge universities to prioritise the hiring of doctoral-trained faculty with specialised expertise in Global Healthcare, Global Leadership, and Evidence-Based Practice.

04

Call for a leading university to establish the first Doctor of Philosophy (DPhil) in Global Healthcare Leadership, positioning itself as a pioneer in advancing this interdisciplinary field by training the next generation of scholar-practitioners.
